2. The Examinations will be subject to the syllabus and the rules applicable read with the Sindh Civil Servants (Departmental Examinations) Rules 1978 in light of Standing Orders of board of Revenue, Sindh and as per Sindh Public Service Commission (Function) Rules 2022/SPSC RMR, 2023.

3. The candidates should send their particulars on the prescribed proforma through their **Appointing Authority**. A challan of Rs. 500/- (Rupees five hundred only) duly paid under the Head of account "**C02101 - Organ state of Examination Fees (Sindh Public Service Commission Receipts)**" (in original) should also be enclosed with the application form. The Prescribed Proforma, duly countersigned by the Competent Authority, should reach Sindh Public Service Commission Head Office not later than **(26.05.2026) (Tuesday)**. The candidates whose particulars are not received from the concerned Administrative Department on or before closing date or they fail to enclose required Challan of Examination fee duly paid in the correct Head of Accounts, shall not be admitted to the Examination.

4. If the Departmental Examinations contain two parts, separate Examination fee of **Rs. 500/- (Rupees Five Hundred only)** is to be paid for each part of the said Departmental Examination. The prior special permission for appearing in the Both Parts of examinations, simultaneously, is essential for admission in the 2nd part.


5. The number of attempts made by the candidate previously with result thereof should clearly be indicated otherwise the application will not be entertained.

Those candidates who could not secure 35% or more marks in previous attempt of Revenue Qualification Examination will not be considered as eligible candidates as per Standing Orders of Board of Revenue, Sindh at Note 08-A at page No. 290 for concerned Examination of Revenue Qualifying Examination, excepting Special Permission issued by Honourable Senior Member Board of Revenue, Sindh.

7. If a candidate, admitted in the Examination is unable to appear for any reason, he should send such intimation to the Additional Controller of Examinations, Sindh Public Service Commission, Hyderabad at least **07 days** before the date of commencement of Examinations.

8. **NO APPLICATION SHALL BE ENTERTAINED IF RECEIVED AFTER THE EXPIRY OF CLOSING DATE i.e. 26.05.2026 (Tuesday).**
