The Examinations will be subject to the syllabus and the rules applicable read with the Sindh Civil Servants (Departmental Examinations) Rules 1978 in light of the Rule-8(1) of the Registration Rules 1940 amended on 20.07.2022. The Departmental Examinations for Assistant (BPS-16) falling under Rule-4 of Sindh Civil Servants (Departmental Examination Rules, 1978). Standing Orders No.07 and as per Sindh Public Service Commission (Functions) Rules, 2022, and RMR, 2023.
- 5. The candidates may send their particulars on the prescribed proforma available on Sindh Public Service Commission Official website through their **Appointing Authority**, along-with a challan of Rs: 500 (Rupees five hundred only) duly paid under the Head of Account "CO2101 Organ of state **Examination Fees (Sindh Public Service Commission) Receipt"** (in original). The Prescribed Proforma, duly countersigned by the Competent Authority, may reach Sindh Public Service Commission Head Office not later than O2-02-2024,(Friday). The candidates whose particulars are not received from the concerned Administrative Department on or before closing date or they failed to enclose required Challan of Examination fees duly paid in the correct Head of Accounts, shall not be admitted to the Examination.
- 6. If a candidate, admitted in the Examination is unable to appear for any reason, he should send such intimation to the Additional Controller of Examinations, Sindh Public Service Commission, Hyderabad at least **07 days** before the date of commencement of Examinations.

7. NO APPLICATION SHALL BE ENTERTAINED IF RECEIVED AFTER THE EXPIRY OF CLOSING DATE i.e. 02-02-2024, Friday.
