PRESS RELEASE

In pursuance to orders of Honourable High Court Sindh at Karachi dated: 09.11.2020, 24.02.2023 and 29.04.2023 in CP. No.D-8033 of 2019 required SPSC to hold the CCE 2020 examination (Afresh) under the supervision of learned Official Assignee, Sindh High Court. The Sindh Public Service Commission after holding the written examination & declaring the written result vide Press Release No.PSC/EXAM(S.S)/2024/634 dated 26.03.2024, interviewed the eligible candidates at Hyderabad and Karachi in the months of April and May, 2024.
